


# Florida Medicaid (Managed Medical Assistance) Outpatient Prior Authorization Change

Prior authorization requirements for many outpatient services are being removed; post-service reviews may apply



Effective May 22, 2015, prior authorization for many services for Florida Medicaid (MMA) will no longer be required. In keeping with existing processes for other services that do not require authorization, Optum will apply algorithms to identify practice patterns that appear to fall outside of typical patterns. When a pattern of care is atypical or does not match guidelines for service level, a telephonic review for medical necessity will be initiated.

- Effective May 22, 2015, you no longer need to call for authorization for many HCPCS services
- A list of HCPCS service codes that will no longer require prior authorization is posted to Provider Express

## Florida Medicaid MMA (Managed Medical Assistance) Outpatient Prior Authorization Change for Contracted Providers

### Effective May 22, 2015

- Prior authorization for many Outpatient and Telemental Health Services (codes listed below) is no longer required for Florida Medicaid (MMA) members
- Optum will apply algorithm to identify practice management patterns that appear to fall outside of typical patterns
- When a pattern of care is atypical or does not match guidelines for service level, a telephonic review for medical necessity will be initiated
- Use of the applicable code modifiers are required for billing of services

The two tables below reflect Agency for Health Care Administration (AHCA) descriptions for the codes listed.
