- The number of traumatic events Americans most commonly experience in their lifetime is 3
- The number of traumatic events fire fighters experience in one year is 4
- The average fire fighter's career is 20-30 years.
- Multiply the average length of career by 4 and a fire fighter is likely to experience 80-120 traumatic events throughout their career.

MAP Overview



- MnFIRE Assistance Program (MAP) is driven to ensure firefighters and their family members get the assistance they need to improve emotional wellness.
- Funded by the Hometown Heroes Assistance Program (HHAP), services remain confidential.
- Firefighters and their family members receiving this service have no financial responsibility—no deductible, copayment or co-insurance.
- MAP is designed as a brief counseling intervention for firefighters and their families.
- Unlike a traditional EAP network, MAP requires clinicians have expertise with treating Police/Firefighters to participate in this exclusive network.
- MAP offers a premium provider reimbursement rate
- MAP requires an authorization.
- Billing must include HJ modifier and is limited to certain CPT codes.





MAP Seeking Care - Plan Design



- MAP authorizations will extend up to 5 counseling visits a year, per diagnosis.
- The sessions are not designed to provide an ongoing course of psychotherapeutic treatment.
- After the MAP visit limit is reached, firefighters and their family members may transition to their behavioral benefit should the patient and their clinician determine this is the best course of treatment.





MAP Seeking Care - Exclusive Provider Network




- MAP has their own exclusive network of PhDs and Masters Level providers that will be attached to this network in the Optum system.
- MAP requires expertise with firefighters to treat MAP firefighters and their family members.
- Clinicians must have "Police/Firefighter Area of Expertise indicated in their Optum profile.
- Clinicians are listed in the Live and Work Well (LAWW) on-line MAP directory with a MnFIRE Preferred Provider banner designation.
- Clinicians in the MAP network are expected to accept eligible firefighters and their family members within 5 business days of the appointment request.
- Clinicians should not treat a firefighter or their family members unless they are an eligible MAP participant.





MAP Seeking Care and Scheduling - Authorizations



- Firefighters or family members call the MnFIRE Helpline at 1-888-784-6634 and select the MAP Program choice.
- Once determined a provider referral is needed, MAP staff will offer to assist firefighter or family member to find MAP participating providers.
- Firefighter or family member shall receive an authorization number and receive a copy of the authorization letter by mail or email.
- Firefighter or family member will call MAP participating provider to schedule an appointment.
- When an individual is scheduling an appointment, the provider should inquire about the MAP authorization number, effective dates and expiration dates, and whether any of the authorized visits have already been used.
- Remind the individual to bring the authorization letter to their first appointment.
- Providers may also 1-866-694-9662 to verify MAP authorization details.
- A new MAP authorization is required when a new benefit year begins. (Providers can refer to the AUTH's expiration date on the MAP authorization letter).





Submitting Claims



- MAP providers will receive a premium reimbursement rate for eligible services.
- Optum pays providers directly no patient financial responsibility.
- The firefighter or their family member ID is a 9-digit number on the authorization form.
- All MAP claims must include an HJ modifier.
- Claims must also include the MAP authorization number to ensure MAP reimbursement rates for eligible services.
